Handling	<ol> <li>Take all precautions mentioned in this document and operate the battery within the temperature range of -20°C and 45°C.</li> <li>No special protective clothing required for handling individual cells in corrective operational method.</li> <li>Improper handling of lithium ion battery may result in injury or damage from electrolyte leakage, heating, ignition or explosion. So do not crush, pierce, short cell/battery terminals with conductive material; Do not directly heat or solder; do not throw into fire; do not place cell/battery in non conductive trays.</li> </ol>
